

# **Introduction to Recognizing and Detecting Counterfeit and Altered Government Issued Driver Licenses, Legal Documents, and Identity Cards**

**This course is directed to those people who should or need to have a working knowledge of legitimate government issued drivers licenses and identification cards and yes even counterfeit money and credit cards. Knowing how to check for fraud and what to look for and the questions to ask may make your job a lot easier. Whether working as someone who accepts these cards for services such as food stamps, financial loans, notarizing documents, store clerks, etc., or as a Law Enforcement or Security Officer, you need to be aware of what is being used by people attempting to fraudulently obtain these services and the false drivers license and identification cards that are being produced everyday.**

**If you are a law enforcement officer this is a must class and may be used for P.O.S.T. certifications upon approval. As a Security Professional you may also use this class to meet the continuing education requirements required by the law, upon approval.**
